



Our committees review applications and consider **community impact**, **organization capacity**, **program/project sustainability** and **collaboration** as required criteria for most projects and programs.

GRANT TYPES



Organization Development Grants	Opportunity Grants	Community Impact Grants	
Designed to retain a consultant to help existing nonprofits strengthen themselves organizationally, increasing their capacity to govern and achieve long-term sustainability. *70% of Consultant Costs, generally up to \$5,000.00	Program or investment grants with a request amount of \$10,000 or less.	Can be Program grants, designed to stimulate and help launch new programs and projects; or to help focus, enhance, and/or expand an organization's existing programs and services. OR Investment grants, which are a critical enhancement to the mission of the nonprofit organization and will increase the organization's capacity to fulfill its mission.	
Available throughout Beaufort, Colleton, Hampton and Jasper Counties		Organizations that "serve people living and/or working south of the Broad River" - greater Bluffton; Hilton Head and Daufuskie Islands

GRANTMAKING



We look to fund projects that empower individuals and do not create dependency, have long lasting benefit and can be sustained by the organization once the grant period is over. We are looking for projects based on best practices and supported by Board and Executive levels in the organization. If the project is being done by others, we ask you to work collaboratively with them. We generally do not fund a duplication in services. Successful applications often demonstrate significant impact on disadvantaged members of the community or the environment.

Limitations



GRANTS ARE GENERALLY NOT AWARDED FOR A PROJECT THAT


- Is already started, already in place, or already funded by CFL
- Is an operating expense, or a pre-assumed commitment
- Lacks strong sustainability plans
- Is a fundraising event/tool or part campaign
- Supports religious or political activities
- Provides subgrants, subawards, stipends or scholarships
- Supports travel for class trip, sports teams, performing groups, etc.



Trick Questions Important Info Covered in this material!



- Where do I send my LOI? You don't. When you enter the access code for an Opportunity Grant or an Impact Grant the LOI will open. You will complete that "Preapplication form" online in the portal and submit it on OR before the due date. The committee will review the LOI and staff will open the Application form IF the LOI is approved.
- Can I apply for operating expenses? Unfortunately, we cannot fund operating expenses.
- Will you fund a new or existing position? Our committee will consider a NEW position that is essential for a NEW project or program. They will currently not fund general and administrative positions (including E.D.'s, Development Officers, etc.)
- Will you fund an existing program? We prefer to fund new programs or existing programs that have been expanded. Our goal is to build and not merely maintain. We will consider existing programs that are VERY impactful, as evidenced by years of measurable outcomes, but all things being equal, our preference is to fund "new" or "expanded" projects or programs.
- My organization is not located in your service area, can I still apply? With approximately 1,200 501(c)(3) charitable organizations in our service area, we have a lot of community partners to support. You can apply, but we encourage you to find a local partner to collaborate with.
- What if I need to reschedule my site visit? Given the number of applications we receive and the activity level of ALL our nonprofit partners, committee members and staff, it is impossible to work around everyone's schedule. We ask you to hold the date range allocated for site visits, knowing it may note be ideal for everyone. If your scheduled time does not work for you, we ask you to have someone else from your organization participate in the site visit on your behalf!

Application Tips



Clearly Make Your Case ...

Don't forget to tell, who, what, why and how.



As you complete your application. Remember to cover all the bases necessary to make your case. What are you doing, who is benefiting, how will you implement and what do you hope to achieve. Explain your timeline, be realistic in your expectations! We receive many applications and cannot fund them all.

Keep in mind the following question: Why is this project (investment in the community) the best use of CFL's grantmaking dollars?

- **Do I need to attend an Impact Information Session?** We are hosting two Impact Information Sessions prior to each Impact Grant Cycle. These sessions are required for first time grant seekers and encouraged for organizations that have received a Community Investment Grant in the past.
